

collects recyclable and non-hazardous IV drip bags, oxygen masks and oxygen tubing from numerous hospitals in South Africa, processes the material at its own factory where it is made into durable shiny school shoes ready for donation to children in need! To date we have recycled nearly 80 000kgs of healthcare waste that would have ended up in hazardous landfill sites. We have donated more than 100 000 pairs of shoes nationally!

## **Dear Delegate**

With increasing population, urbanization and expanding economic activities, Solid waste disposal and management is a challenge in Africa.

Waste is one of the biggest challenges faced by the world today, and the future of solid waste management depends on every single individual. Although government authorities, leaders of the nations, municipalities and local communities are working hard to manage the extensive amount of waste generated every day, a radical change in mindset at an individual level is the need of the hour.

On a broader note, improper waste disposal and management, which includes public littering, lack of waste segregation, uncontrolled collection and disposal and poor waste treatment practices, have greatly impacted the world. According to a World Bank report, 2.01 billion tons of municipal solid waste is generated every year across the world, out of which it is estimated that 33% is not managed properly, impacting the environment.

The growing waste problem causes health hazards, especially among the poor who reside near landfills. The mismanaged waste on the roadside may lead to the transmission of diseases and affect public health. Animals also get affected by consuming plastics and toxic waste. The waste accumulation over time pollutes water bodies and ultimately disturbs the natural balance of the environment.

Besides, improper waste disposal and management directly affect the economy of a country by minimizing income opportunities from tourist destinations and spots maligned by the waste problem. Also, greenhouse gases emitted from waste contribute to climate change as well.

Rapid population growth and urbanization in Africa has led to people generating enormous quantities of solid waste and consequent environmental degradation. The waste is normally disposed in open dumps creating nuisance and environmental degradation. Solid wastes cause a major risk to public health and the environment. Management of solid wastes is important in order to minimize the adverse effects posed by their indiscriminate disposal. Waste sources range from residential, industrial, commercial, institutional, construction & demolition, municipal waste, process (manufacturing) and agriculture and all these end up in landfills.

Plasma gasification, a process which converts organic matter into synthetic gas, electricity, and slag using plasma is one of the most efficient and widely used methods used in developed countries to process waste. Inside the gasifier, the hot gases from the plasma torch or arc contact the feedstock, such as municipal solid waste, auto shredder wastes, medical waste, biomass or hazardous waste, heating it to more than 1,649 degrees Celsius. This extreme heat maintains the gasification reactions, which break apart the chemical bonds of the feedstock and converts them to a synthesis gas (syngas). The syngas which consists primarily of carbon monoxide and hydrogen is then used for basic building blocks for chemicals, fertilizers, substitute natural gas, and liquid transportation fuels

In South Africa over 90% of all general and hazardous waste is landfilled hence, the conference seeks to address and highlight alternatives that, when put in place and managed properly would see the reduction of waste going to landfills. It will address amongst others, plasma gasification, recycling, anaerobic digestion, composting, mechanical biological treatment, waste to energy, food recycling, glass recycling, medical waste, plastic recycling, construction waste and waste minimization initiatives case studies in Africa.

There is much to be done and to achieve our shared ambitions we will need to work together, to forge alliances between authorities, waste and recycling companies, manufacturers, small businesses and residents alike to save the planet for our children and grandchildren.
